GENERAL NOTES AND INCLUSIONS:

- The Subcontractor is responsible for all Blue Staking and locating of existing utilities, with verification by Contractor with As-Builts and Private Blue Stake
- b) Survey request will be provided to Contractor with a minimum of 72-hour notice by Subcontractor. Subcontractor will be responsible to maintain survey layout.
- c) Construction water source is provided by Contractor.
- d) Subcontractor acknowledges that project schedule will be 5 nights a week, 8-hour shifts. Per Project CPM Schedule.
- e) Subcontractor will be responsible to coordinate dust control of their work with Contractor's water truck.
- f) Contractor will not provide any hoisting or equipment for the movement of equipment and materials.
- g) Security of materials stored on site is Subcontractor's responsibility.
- h) Subcontractor is responsible for timely submittals, re-submittals, RFI's and other project management functions so as not to negatively affect the project schedule.
- i) Subcontractor will provide an on-site superintendent/manager dedicated to the project that will be responsible for daily coordination meetings, weekly Owner meetings, 5-week schedules and other project management.
- j) Actual premium cost of the bond required hereunder shall be reimbursed by Contractor up to a maximum of 3% of the total Sub-subcontract amount. Reimbursement to be made upon submission to Contractor of an original paid and/or original receipted invoice from the surety or agent for the bond premium.
- k) Subcontractor is responsible for having employee personnel attend the Airport Security Badging Training as specified in Section 36-3.8 of the project specifications and carrying insurance per the requirements of the Contract Documents.
- Subcontractor is responsible to include the cost for Airport Security Badging Training in their pricing and will not be separately reimbursed for the cost of employee Airport Security Badging Training.
- m) Subcontractor is responsible for flashing amber beacons on all equipment and vehicles, including hauling trucks and delivery trucks, at all times during construction.
- n) Subcontractor is responsible for "Orange and White" checked airport flags on all equipment, including hauling and delivery trucks at all times during construction.
- o) All vehicles operating within the airfield boundary be identified with a painted or magnetic sign on each side of the vehicle bearing the name and logo of the company.
- p) Parking onsite will be designated by the Contractor. Subcontractor is responsible for their employees' transportation on-site.
- q) Unit Prices must include Vacuuming / Sweeping of slurry/ debris caused by saw cutting operations.

SCOPE OF WORK:

- a) Quantities are based on actual field measurement
- b) Excess debris/material can be dumped onsite at location denoted by Contractor. Any haul-off generated from removals, the Contractor must approve disposal location prior to transporting off-site. Onsite washout will be provided by the Contractor.
- c) The unit costs developed above shall be inclusive of all hours worked, including overtime, night, and weekend work, and note special times of night work only.
- d) Material escalations through project schedule shall be included in unit price.

- e) Saw cuts will be laid out by Contractor at 40' intervals.
- f) Saw cuts shall be straight no more than 1/2" in 20' off line.
- g) Spalls, overcuts, and damage to existing/new concrete, materials, and structures, caused by Subcontractor operation shall be repaired and/or fixed per Owners direction at no additional cost to the Contractor or Owner.
- h) Subcontractor shall be responsible for the vacuuming/sweeping and cleanup of all construction mess caused by Subcontractor activities.
