(Meter pedestal) Is a single phase 3 wire system, with a maximum supply of 100 amps and a supply voltage of 120/240. I've included a cut sheet example and a photo for reference, which details the APS approved meter pedestal at the Hunt and Franklin intersection.

Our current TS2 type 1 cabinets are NEMA Eagle Mobotrex cabinets measuring 56" H x 44" W x 26" D, mounted on an 18" base with accessible front and rear doors. The Alpha BBS enclosure, equipped with slide-out battery drawers and a generator plug connection, is mounted to the right side of the cabinet. The dimensions are (inches 48H X 22W X 16.5D) system also includes an Alpha FXM-HP1100 inverter with a remote battery management system and four 195XTV batteries.
